AGREED ORDER OF COMPLETION

This matter is before the Board pursuant to an agreement of the parties for disposition of these proceedings, including OAH No. 09DB0002, based on successful completion of disciplinary action. The Kansas Dental Board (the "Board") appears by and through its counsel, Kevin M. Fowler. Donald I. Pfuetze, DDS (the "Licensee") appears by and through his counsel, Arthur A. Glassman. There are no other appearances.

On or about May 9, 2009, the Board entered a Stipulation and Consent Order ("Order") requiring the Licensee to pay a \$1000 fine and to obtain 16 hours of dental education on the topic of crown and bridge and 8 hours on periodontics within 6 months of the effective date of the order. The fine of \$1000 was paid prior to November 2008, however, the required continuing education hours were not received within the time frame of the Order.

AGREED ORDER OF COMPLETION

Matter of Donald I. Pfuetze, DDS, Case No. 06-150 (Kan. Dental Bd.)

On or about April 2, 2009, the Board issued a Summary Order imposing a second fine of \$1000 for failure to complete the Board-ordered continuing education hours by the deadline specified in the Order.

During May 2009, the licensee provided the Board evidence that he successfully completed the remaining continuing education hours required under the Order and he timely paid the Board a second fine of \$1,000 as directed in the Summary Order.

In consideration of the Board's determination that the Licensee has successfully fulfilled his obligations under the Order and Summary Order, the Licensee has agreed to withdraw his request for a hearing and to dismiss his appeal in this matter. A copy of this Order of Completion shall also serve as the Licensee's request to withdraw his request for a hearing in Kansas Dental Board Case No. 06-150 and OAH No. 09DB0002 and it shall constitute the stipulation and agreement of the parties to dismissal of all hearing or appellate proceedings herein.


Upon withdrawal of the Licensee's request for a hearing and dismissal of OAH No. 09DB0002, this proceeding shall be deemed complete and administratively closed without further action by the Board.


