## A Patient Is Entitled To His Or Her Records

On a weekly basis, the Board office receives numerous inquiries regarding whether a patient is entitled to a copy of his or her dental records, including diagnostic quality x-rays and notes. Quite often, these inquiries come from a patient who files a complaint against a dentist who refuses to release the patient's records.

Generally, a patient or a patient's authorized representative has the right to a copy of dental records,

including diagnostic quality x-rays and notes. A dentist can charge a fee for the patient's records. The fee, however, must comply with K.S.A. 65-4971.

Records are not intended to be withheld until the patient satisfies an outstanding balance for work already performed. Moreover, under K.A.R. 71-1-15, a dentist must retain patient records for 10 years from the last day of

service. The records can be retained digitally.

## Legislative Updates and Regulatory Changes

**2011 Legislative Session.** The Kansas Dental Practices Act underwent changes during the 2011 legislative session. The changes allowed for dental franchises in Kansas. The dental franchise laws are now found in K.S.A. 65-1470 and K.S.A. 65-1471. A copy of the Kansas Dental Practices Act and related laws may be found on the Board's website.

**2012 Legislative Session.** During the current legislative session, the Kansas Dental Association is sponsoring H.B. 2631. The bill would make several additions and

changes to the Kansas Dental Practices Act for the purpose of expanding dental service in the state. The bill would add a third level of extended care, which would be offered by registered dental hygienists who meet the increased qualifications for the Extended Care Permit III (ECP III). The Kansas Dental Board supports the ECP III proposal. Additionally, the bill would require the Kansas Board of Regents to try to create additional seats for Kansas residents at UMKC School of Dentistry and establish a special volunteer


license for dentists who are retired from active practice and wish to donate their expertise for the treatment of the dentally indigent and underserved.

**BCLS Card Now Required For Renewal Of License.** Effective January 6, 2012, K.A.R. 71-4-1 was amended to require each licensee to submit, with the license renewal application, a current basic cardiac life support for the health care provider certificate. The BCLS card is in addition to the required continuing education hours.

## Nitrous Oxide Courses For Dental Assistants and Registered Dental Hygienists Must Be At Least 16 Hours

During its public meeting on Friday, January 20, 2012, the Board considered the minimum number of hours required for approval of a course of instruction on the administration and monitoring of nitrous oxide. The Board reviewed the requirements of K.S.A. 65-1444(b) with the assistance of legal counsel.

K.S.A. 65-1444(b) reads: “A dentist may utilize

an assistant not licensed by the board in the administration and monitoring of nitrous oxide or oxygen, or both, if that person is certified in cardiopulmonary resuscitation and has satisfactorily completed a course of instruction which has been approved by the board. To be approved by the board, the course of instruction shall include a minimum of six hours of instruction at a teaching institution

accredited by the American dental association and include satisfactory completion of courses which offer both didactic and clinical instruction in: (A) Theory of pain control; (B) anatomy; (C) medical history; (D) pharmacology; and (E) emergencies and complications.”

After discussion, the Board determined that dental assistants and registered dental hygienists will be required to take a course of at least 16 hours.



## Groupons, Social Coupons, and The Prohibition Against Fee-Splitting

The daily deals are popping up everywhere. Daily-deal sites, such as Groupon and LivingSocial, offer limited-time discounts on a wide range of goods and services, such as restaurant meals, clothes, cruises and weekend getaways. Now, across the nation, dental services are starting to appear more frequently as a daily-deal.

Kansas dental services are no exception to the daily-deal phenomenon.

As a result, the Board recently reviewed the statutory prohibition against fee-splitting found in K.S.A. 65-1436(a)(7). Without reviewing each merchant agreement between a social coupon merchant and a dental office, it is difficult to con-

clude that each agreement violates the fee-splitting prohibition found in K.S.A. 65-1436(a)(7). For this reason, the Board encourages dental offices across Kansas that intend to use, or are using, the services of a social coupon merchant to ensure that the merchant agreement does not violate the fee-splitting prohibition.

## Advertising On Facebook® And Social Media

The Board office receives a high number of inquiries regarding advertising on Facebook® and through other forms of social media. Facebook® and social media users are encouraged to ensure that all forms of advertising avoid improper fee-splitting arrangements under K.S.A. 65-1436(a)(7). Further, advertising should comply with the various limitations and requirements found in K.S.A. 65-1437 and K.A.R. 71-7-1.

## Continuing Education Audits

The continuing education requirements for dentists and hygienists are outlined in K.A.R. 71-4-1. Each year, a select number of dentists and hygienists are chosen at random by a computer program to submit proof of continuing education certificates. The random audits are currently underway. From time to time, some of those randomly chosen for audit are unable to provide proof of continuing education certificates. Failure to properly report continuing education hours or failure of an audit could result in disciplinary action.

## Dental Laws and Regulations

A large portion of the Board's work includes the application and interpretation, through the assistance of legal counsel, of the Kansas Dental Practices Act. ## Board Members Participate In 2012 KMOM

On February 17-18, 2012, the Kansas Dental Charitable Foundation held its signature event, the Kansas Mission of Mercy (KMOM), in Kansas City, Kansas. According to the Kansas Dental Charitable Foundation, the event resulted in the treatment of 2,144 patients with \$1.5 million in free dental care. The event was the largest KMOM clinic ever.

## Disciplinary Actions

**David G. Hall, D.D.S., License #6200 of Wichita, Case 11-84.** Dr. Hall was the subject of a random continuing education audit and failed to provide documentation that he had attended at least 60 hours of continuing education and proof of liability insurance. Dr. Hall paid a \$1,000 fine and, if he is unable to provide proof of 60 hours of continuing education

or complete the requisite hours within 60 days, he will have to pay an additional \$4,000.

**Anita M. Knox, D.D.S., Case 10-94.** Dr. Knox entered into an Agreed Settlement Order in Texas for falling below the minimum standard of care in the treatment and recordkeeping for a patient. Dr. Knox is required to maintain compliance with the

Texas Agreed Settlement Order and take the Kansas Jurisprudence Examination within 60 days.

These cases were resolved through Stipulation and Consent Orders approved by the Board on January 20, 2012. The orders are public records in the custody of the Kansas Dental Board.
