SUMMARY ORDER –Fine \$1000, possible suspension of license until course is completed. CASE# 08-111

Dear Dr. Hudson:

The Investigative Committee of the Kansas Dental Board has reviewed your compliance with the Stipulation and Consent Order dated Nov 5, 2010. On behalf of the Board you are being fined \$1000.00 for failure to comply with the Consent Order by not having completed the refresher course on restorations as required. This additional discipline is based upon the following:

FINDINGS OF FACT

- 1. The Stipulation and Consent Order with the Board was approved by the Board on November 5, 2010. The Order was mailed to the licensee on November 10, 2010 and became effective on Nov. 13, 2010.
- As part of the Order the licensee was ordered and agreed to complete (Paragraph 6.B.) a refresher course in the area of dental restorations within 90 days of the effective date of the order.
- 3. The date the refresher course was to be completed was February 14, 2011.
- 4. To date, no evidence of course completion has been provided to the board.
- K.S.A. 77-537 of the Kansas Administrative Procedure Act authorizes the use of summary proceedings.
- 6. The Stipulation and Consent of Order filed Nov. 5, 2010 has been violated by the licensee, subjecting her license to further sanctions of the board.

CONCLUSIONS

 Within 15 days of the effective date of this Order, the Licensee shall pay to the Board An additional administrative fine in the amount of One Thousand dollars (\$1,000.00).

NOTICES

- 8. Failure to provide evidence of the successful completion of a refresher course within 30 days as agreed and ordered by the board will result in <u>immediate suspension of your dental license</u>, until evidence of the successful completion of the required refresher course is provided to the board.
- Pursuant to K.S.A. 77- 537, you may request a hearing on this Summary Order by Mailing or faxing a written request to:

within fifteen (15) days of the date of service of this order. If a hearing is not requested as described above, the order shall become a final order of the Board, effective upon the expiration of the time to request a hearing. Within fifteen (15) days after entry of a final agency order; either party may file a petition for reconsideration pursuant to K.S.A. 77-529.
